

ORDINANCE No. 2016-06

**A CHARTER ORDINANCE ABOLISHING SEPARATE DEPUTY CLERK & TREASURER OFFICES & CREATING A DEPUTY CLERK-TREASURER POSITION**

The Village Board of the Village of Wausaukee, Marinette County, Wisconsin, do ordain as follows:

**SECTION I. REPEAL OF PROVISIONS; ADOPTION OF PROVISIONS.**

Section 2-3-5 of the Village of Wausaukee Code of Ordinances is repealed and Section 2-3-5 is recreated to read as follows:

**Sec. 2-3-5 Deputy Clerk-Treasurer.**

Pursuant to Section 66.0101, Wis. Stats., the Village of Wausaukee elects by this Charter Ordinance not to be governed by the provisions of the Wisconsin Statutes pertaining to the selection, tenure and appointment of separate deputy clerks and deputy treasurers. The position of Deputy Clerk-Treasurer is hereby created. The Village Clerk-Treasurer may appoint a Deputy Clerk-Treasurer, subject to confirmation by majority vote of the Village Board. The Deputy Clerk-Treasurer shall have an indefinite term of office, subject to removal as provided in Sec. 17.13, Wis. Stats. The Deputy Clerk-Treasurer shall act under the direction of the Village Clerk-Treasurer and, during the temporary absence or disability of the Clerk-Treasurer or during a vacancy in such office, shall perform the duties of the Village Clerk-Treasurer. The acts of the Deputy Clerk-Treasurer shall be covered by an official bond as the Village Board shall direct.

**SECTION II. SEVERABILITY.**


If any provision of this Ordinance is invalid or unconstitutional or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.

**SECTION III. EFFECTIVE DATE.**

This Charter Ordinance, pursuant to Section 66.0101, Wis. Stats., shall take effect sixty (60) days after passage and date of publication as provided by law. A certified copy of this Charter Ordinance shall be submitted by the Village and filed with the Wisconsin Secretary of State.
