Contact will be made with the Szweda family first to see if they are interested in giving the Village an easement.
- 4. Discussion Relocate Evergreen Campground Sign. The committee discussed moving the sign out of the proposed WisDOT right-away but in the same general area. Clerk Ranallo will contact a private property owner to see if they would be willing to give the Village an easement to put the sign on the corner of their property.
